

In 2018, the Pingtung Branch Administrative Enforcement Agency collected NT\$582.11 million, NT\$43.07 million more than in 2017. Of the total amount, the collection from financial and tax cases accounted NT\$241.32 million, or 41.5%. It was followed by NT\$123.44 million from health insurance cases, NT\$101.28 million from fine cases and NT\$116.07 million from fee cases. The last three items accounted for 21.2%, 17.4%, and 19.9%, respectively.
